JANUARY 8, 2018

NEW BUSINESS:

NET GROUP: A representative from the NET Group presented council with a contract/agreement for website services for the town. She advised that the agreement was for a period of three years with data and additional emails being added as well. There was discussion with the Attorney advising that data needed to be added and additional emails would be beneficial also. He also noted that a clause regarding termination of the agreement by either party was not included. A motion was made/second to continue website services with the NET Group until an updated agreement could be prepared and reviewed by the Attorney within eight weeks. Motion carried.

CHAMBER OF COMMERCE: Betsy Thomason presented council with a schedule of events planned by the Chamber for 2018 for review and approval. She also advised that the Dec. 1 date for the Christmas Parade was made due to other towns holding their parades on other dates. A motion was made/second to approve the Chamber's schedule of events for 2018 . Motion carried. It was noted that minor repairs needed to made to the caboose at the train depot Mayor Jackson stated that he would have town employees make them as needed.
